RESOLUTION NO. SP. 6911 , S-2016

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE MUNICIPAL MAYOR OF PANDI, BULACAN, HONORABLE CELESTINO T. MARQUEZ, AND FOR THE GRANTING OF FINANCIAL ASSISTANCE TO THE MUNICIPALITY OF PANDI, BULACAN, IN THE AMOUNT OF TEN MILLION PESOS (PHP10,000,000.00) FOR THE DELIVERY OF BASIC SERVICES FOR THE WELL-BEING PRIMARILY OF THE RELOCATEES FROM QUEZON CITY.

WHEREAS, the Municipality of Pandi, Bulacan (LGU-Pandi) has accommodated the relocation of Four Thousand Nine Hundred and Eighty Two (4,982) informal settler families (ISFs) from Quezon City to NHA Resettlement Sites in the said municipality;

WHEREAS, such relocation activity lead to the significant increase of population in the Municipality of Pandi and resulted to the increase in demand for support services on education, health, sanitation and livelihood among others which strains the limited resources of the Municipality;

WHEREAS, the Municipal Mayor of Pandi, Bulacan, Hon. Celestino T. Marquez, in his letter dated August 10, 2016 has sought the assistance of the Quezon City Government in the form of financial support for the delivery of services for the well-being of the said relocatees, a copy of said letter is hereto attached as Annex "A";

WHEREAS, the Quezon City Government has deemed it proper to provide the Municipality of Pandi and to the Department of Education Region III – Division of Pandi North in the amount of Ten Million Pesos (Php10,000,000.00) to be utilized as follows:

- Php 6.0 M for the salaries/honoraria of Local School Board teachers in resettlement areas, electricity bills, installation of water pump, provision of sports equipment and audio-visual room with equipment, other supplementary teaching materials and construction of school fences;
- Php 4.0 M for the municipal services on health, sanitation and livelihood programs for the relocatees in the municipality;

WHEREAS, the Sangguniang Bayan of Pandi passed Resolution No. 58, S-2016 on August 22, 2016, authorizing the Municipal Mayor, Hon. Celestino T. Marquez, for and in behalf of the Municipal Government of Pandi to receive the Ten Million Pesos (Php10,000,000.00) financial assistance from Honorable City Mayor Herbert M. Bautista of the Quezon City Government;

WHEREAS, to cause the transfer of the aforementioned financial assistance fund, from LGU-QC to LGU-Pandi, there is a need for the parties to enter into a Memorandum of Agreement (MOA) which shall contain the terms and conditions for the transfer of said fund;

WHEREAS, pursuant to Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991", the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Herbert M. Bautista, to enter into a Memorandum of Agreement (MOA) with the Municipal Mayor of Pandi, Bulacan, Honorable Celestino T. Marquez, and for the granting of financial assistance to the Municipality of Pandi, in the amount of Ten Million Pesos (Php10,000,000.00), from any supplemental funds available for the provision of basic services for the well-being of the relocatees in the municipality.
