RESOLUTION NO. SP- **6916**, S-2016

A RESOLUTION URGING CONGRESS OF THE PHILIPPINES TO ENACT A LAW THAT WILL AUTHORIZE THE SALE OF PAEL COUMPOUND BARANGAY CULIAT, QUEZON CITY, TO ITS LEGITIMATE RESIDENTS FOR SOCIALIZED HOUSING PROGRAM OF THE GOVERNMENT AMENDING FOR THE PURPOSE REPUBLIC ACT. NO. 9500, OTHERWISE KNOWN AS THE UNIVERSITY OF THE PHILIPPINES CHARTER OF 2008.


NOW, THEREFORE,


