RESOLUTION NO. SP- 6917, S-2016

A RESOLUTION URGING CONGRESS OF THE PHILIPPINES TO ENACT A LAW THAT WILL AUTHORIZE THE SALE OF UPPER AND LOWER FORESTRY, BARANGAY CULIAT, QUEZON CITY, TO ITS LEGITIMATE RESIDENTS FOR SOCIALIZED HOUSING PROGRAM OF THE GOVERNMENT, AMENDING FOR THE PURPOSE REPUBLIC ACT. NO. 9500, OTHERWISE KNOWN AS THE UNIVERSITY OF THE PHILIPPINES CHARTER OF 2008.

WHEREAS, Republic Act No. 7279, otherwise known as the Urban Development and Housing Act of 1992, seeks to uplift the living conditions of the homeless citizens in urban areas by making available to them decent and affordable housing;


WHEREAS, a portion of the University of the Philippines known as Upper and Lower Forestry located at Barangay Culiat, Quezon City are occupied by bonafide residents for more than thirty (30) years;

WHEREAS, the bonafide residents of Upper and Lower Forestry, Barangay Culiat, Quezon City wanted to acquire the land they are occupying through the socialized housing program of the government.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge Congress of the Philippines to enact a law that will authorize the sale of Upper and Lower Forestry, Barangay Culiat, Quezon City, to its legitimate residents for socialized housing of the government, amending for the purpose Republic Act No. 9500, otherwise known as the University of the Philippines Charter of 2008.


