WHERAS, there is a need to find ways and establish a system to eliminate long queues and simplify the processes of securing police clearance from Quezon City Police District by the residents of Quezon City;

WHEREAS, the long queues can be eliminated and the application for securing police clearance can be simplified through an online application and scheduling system;

WHEREAS, applicants can fill up forms online and go to the Quezon City Police District clearance sites on the scheduled date they have chosen which is a fast and a convenient way in securing police clearance;

WHEREAS, President Rodrigo R. Duterte has instructed government agencies, including the Philippine National Police, to create a system wherein people need not endure the bureaucratic application for government papers:

WHEREAS, the QCPD District Director, PSSupt. Guilermo L. Eleazar made representation with City Mayor Herbert M. Bautista for QCPD to adopt an online application and verification system in the issuance of police clearance in Quezon City currently being utilized by the Manila Police District.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the Quezon City Police District to adopt an online application and documents verification system in the issuance of Police clearance in Quezon City.

RESOLVED, FURTHER, that a Systems proposal by any IT company for the online application and documents verification system in the issuance of police clearance in Quezon City be reviewed by the Quezon City Police District in coordination with the Quezon City Information Technology Office before its submission to the City Mayor for final approval and implementation.
