WHEREAS, Section 455 (2) (V) of the same Code provides that the City Mayor shall "exercise general and operational control and supervision over the local police forces in the city, in accordance with Republic Act No. 6975 (The DILG Act of 1990)";


WHEREAS, there is a need to improve the equipment of the police force especially in the field of technological advancement to cope-up with the changing pace in this regard.


RESOLVED, FURTHER, that a copy of this resolution be forwarded to the Office of the City Mayor and the Office of the City Administrator for their information.


