WHEREAS, Senator Sherwin T. Gatchalian filed on June 30, 2016 Senate Bill No. 201 known as the "Proof-of-Parking Space Act" which intends to ease traffic congestion, curb the number of private vehicles and provide for a safe and uncluttered pathways for the benefit of the public; ✓

WHEREAS, it also provides that any person, whether natural or juridical, with residence or business address in Metro Manila who intends to purchase motor vehicle is required to provide an affidavit attesting to the availability of permanent parking space;


WHEREAS, the Senate Bill also mandates the Land Transportation Office, the Metro Manila Development Authority and Local Government Units to conduct frequent ocular inspections of major and a minor thoroughfares across the NCR to remove illegally parked vehicles and to punish vehicle owners who refuse to comply with the law;

WHEREAS, the passage of Senate Bill No. 201 into law will not only lessen traffic problem but will encourage motor vehicle owners to be responsible.


NOW, THEREFORE,






