WHEREAS, the legislative proposal of Senator Poe is not only laudable but timely considering the extremely frustrating statistics of road accidents;

WHEREAS, in her explanatory note, Senator Poe revealed that from 2008 to 2013 road accident is the fifth highest cause of mortality, accounting for 36,000 deaths for every 100,000 population;

WHEREAS, road accidents, which are only man-made, could be prevented or controlled through strict enforcement of the law, greater awareness and education that must commence by inculcating good road safety habits and driver's discipline among the youth;
