A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH HONORABLE MAYOR HERBERT M. BAUTISTA TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE INTENDED FOR MONITORING OF PROGRAMS AND PROJECTS OF THE TRICYCLE FRANCHISING BOARD (TFB) TO BE CHARGED FROM THE OFFICE OF THE CITY MAYOR.


NOW, THEREFORE,


