RESOLUTION NO SP- 8445, S-2021

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO WATERKONSULT EQUIPMENT AND SERVICES, INC., REPRESENTED BY MR. ANTHONY V. GEDANG, PRESIDENT AND CEO, FOR THE ESTABLISHMENT OF BUSINESS (OFFICE ONLY) AT NO. 9026 FERIA ROAD, POOK DE LA PAZ, BARANGAY MATANDANG BALARA, QUEZON CITY, AN AREA CLASSIFIED AS MEDIUM DENSITY RESIDENTIAL SUB-ZONE (R-2-A), ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Waterkonsult Equipment and Services, Inc., through Mr. Anthony V. Gedang, President and CEO, in its letter submitted, requested the City Council to grant a Certificate of Exception for the establishment of business at No. 9026 Feria Road, Pook de la Paz, Barangay Matandang Balara, an area classified as Medium Density Residential Sub-Zone (R-2-A) under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016;

WHEREAS, the City Planning and Development Department, Zoning Administration Unit issued notice/advice of action that the business activity of Waterkonsult Equipment and Services, Inc. is not permissible in the zone, thus, there is a need to secure a Certificate of Exception allowing deviation from the restrictions provided under the Quezon City Comprehensive Zoning Ordinance of 2016;

WHEREAS, the Sangguniang Barangay of Barangay Matandang Balara, District III, Quezon City, adopted a Resolution interposing no objection to the business operation of Waterkonsult Equipment and Services, Inc. as contractor/retailer plumbing installation services (Office Only) at No. 9026 Feria Road, Pook de la Paz, Barangay Matandang Balara, Quezon City;

WHEREAS, Waterkonsult Equipment and Services, Inc. was able to submit the necessary and mandatory requirements prescribed in the issuance of Certificate of Exception.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Certificate of Exception to Waterkonsult Equipment and Services, Inc., represented by Mr. Anthony V. Gedang, President and CEO, for the establishment of business (office only) at No. 9026 Feria Road, Pook de la Paz, Barangay Matandang Balara, Quezon City, an area classified as Medium Density Residential Sub-Zone (R-2-A), allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.
