WHEREAS, B/Gen. Danilo Lim was born on June 2, 1955 in Solano, Nueva Vizcaya, Philippines, where he finished his elementary and high school with flying colors. He was in his first year at the University of the Philippines (UP) when he took the entrance exams in the Philippine Military Academy (PMA) and topped the same;

WHEREAS, Brigadier General Danilo "Danny" Lim is a member of the Philippine Military Academy Makatarungan Class 1978;

WHEREAS, B/Gen. Danilo Lim took the entrance exam to the United States Military Academy (USMA) at West Point, one of the world's premier military academies, because of an outstanding performance as cadet, in which he topped the exams;

WHEREAS, B/Gen. Danilo Lim returned to the country, took the Scout Ranger Course where he graduated No. 1 and led his team in registering the only encounter of the class during their test mission;

WHEREAS, B/Gen. Danilo Lim was a distinguished soldier at the Special Operations Command (SOCOM) where he was the Commander of the Scout Rangers, a special unit in the Philippine Army which specialized in warfare. He opted to be assigned in Jolo and commanded the forward Recon Unit of the 1st Infantry Division (Philippines) in Sulu where he was wounded twice in combat;

WHEREAS, during his time in the military, B/Gen. Danilo Lim bagged various awards, including the Presidential Medal of Merit, Distinguished Service Star, Wounded Personal Medal, Military Commendation Medals, Disaster Relief and Rehabilitation Ribbon, Anti Dissidence Campaign Medal, and the Long Service Medal;

WHEREAS, in 2011 to 2013, he served as Deputy Commissioner for Intelligence in the Bureau of Customs and in 2017 until his death, as Chairperson of the Metropolitan Manila Development Authority (MMDA);

WHEREAS, the contribution of B/Gen. Danilo Lim extends not only to his length of service to the military but to the development of the country's peace and order from the time of the 1986 EDSA People Power Revolution to his invaluable contribution to the MMDA especially during the COVID-19 pandemic.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to extend, as it does hereby extend, the deepest condolences of the Quezon City Government headed by the City Mayor, Honorable Ma. Josefina G. Belmonte, the City Vice Mayor, Honorable Gian G. Sotto, and the Honorable Members of the 21st City Council to the bereaved family of the late Metropolitan Manila Development Authority (MMDA) Chairperson, Retired Brigadier General Danilo Delapuz Lim and expressing grateful recognition to his invaluable and exemplary contribution to the country.




