A RESOLUTION AUTHORIZING THE QUEZON CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE-ALIMURUNG, FOR THE EXECUTIVE DEPARTMENT, AND THE CITY VICE MAYOR, HONORABLE GIAN G. SOTTO, FOR THE LEGISLATIVE DEPARTMENT, TO EXTEND THE CONTRACTS OF ALL CONSULTANTS, CONTRACT OF SERVICE (COS) AND JOB ORDER (JO) EMPLOYEES OF THE QUEZON CITY GOVERNMENT UNTIL DECEMBER 31, 2021 PURSUANT TO PRESIDENTIAL PROCLAMATION NO. 1021, S-2020.

WHEREAS, on March 8, 2020, President Rodrigo Roa Duterte issued Proclamation No. 922, S-2020 declaring a State of Public Health Emergency throughout the country in recognition of the COVID-19 public health event as a threat to national security, and to prompt a whole-of-government approach in addressing the outbreak in the country;

WHEREAS, Presidential Proclamation No. 929, S-2020 signed on March 16, 2020, declared a State of Calamity throughout the country due to COVID-19 for a period of six (6) months;

WHEREAS, on 27 April 2020, the 21<sup>st</sup> City Council passed Resolution No. SP-8171, S-2020 authorizing the City Mayor, Honorable Ma. Josefina G. Belmonte and City Vice Mayor, Gian G. Sotto to extend the contracts of all Consultants, Contract of Service (COS) and Job Order (JO) employees of the Quezon City Government until December 31, 2020;

WHEREAS, Resolution No. SP-8171, S-2020 led to the smooth process of renewal of the contracts of the Consultants, COS, and JOs who are also frontliners of the Quezon City Government including those working in the health services, disaster response, traffic management, social services, among others;

WHEREAS, on September 16, 2020, President Rodrigo Duterte issued Presidential Proclamation No. 1021, S-2020 extending the period of the State of Calamity for one (1) year, or from September 13, 2020 to September 12, 2021;

WHEREAS, Consultants, Contract of Service (COS) and Job Order (JO) Employees of the Quezon City Government are required to renew their contracts this year which would expire on June 30, 2021;

WHEREAS, Consultants, COS and JO employees will be required to physically submit themselves to acquire various services such as their recent drug tests, NBI Clearance, notary of documents and facilitation of oath in the HR Department;

WHEREAS, there is a need to simplify and ensure that the contracts of our Consultants, COS, and JOs are renewed in time to help us ensure the continuous delivery of essential services to our constituents.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Quezon City Mayor, Honorable Ma. Josefina G. Belmonte-Alimurung, for the Executive Department, and the City Vice Mayor, Honorable Gian G. Sotto, for the Legislative Department, to extend the contracts of all Consultants, Contract of Service (COS) and Job Order (JO) employees of the Quezon City Government until December 31, 2021 pursuant to Presidential Proclamation No. 1021, S-2020.

RESOLVED FURTHER, that the extension of contract shall be subject to the pertinent rules relative to the renewal of contracts for Consultants, Contract of Service and Job Order employees and upon the recommendation of the Head of Department or Office.

RESOLVED FINALLY, that all the requirements for renewal, such as but not limited to drug tests and medical examination, shall be submitted before the end of the period of the renewed contract or before December 31, 2021.
