WHEREAS, Section 106 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates each local government unit to prepare a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its Sanggunian;

WHEREAS, the City Development Council, pursuant to the Local Government Code of 1991, is mandated to formulate a long term, medium term, and annual socio-economic development plans and policies;

WHEREAS, through Resolution No. SP-7473, S-2018, the Quezon City Council initially adopted the Comprehensive Plan of the Quezon City Government for the period 2017-2020;

WHEREAS, the present administration of the Honorable Mayor Ma. Josefina G. Belmonte has enabled the update of the City's plans to ensure continuity and stability of policies as well as to introduce innovative ideas intended to propel the City to greater heights of achievements;

WHEREAS, the City Development Council passed a resolution on November 19, 2020 approving the priority list of programs/projects for inclusion in the Comprehensive Development Plan 2021-2025;

WHEREAS, the Quezon City Government, through the City Development Council, has undertaken the revision of the City's Comprehensive Development Plan in view of the significant transformations in the social and ecological conditions of the City since the plan's updating and implementation in 2017;

WHEREAS, the plan revision sought to identify development interventions that correspond to the needs and the present condition of the City and its constituents;

WHEREAS, the Revised Quezon City Comprehensive Development Plan for the period 2021-2025 is aligned with the 14-Point Agenda of the present administration: (1) deliver responsive, efficient, and cost-effective social services; (2) build more homes; (3) provide better healthcare; (4) ensure high quality education; (5) empower citizens of every gender and social class; (6) build safer and more resilient city; (7) make Quezon City the preferred destination for businesses; (8) create new jobs across more businesses; (9) develop growth hubs; (10) build a livable, green, and sustainable city; (11) build essential infrastructure; (12) be a model of good governance; (13) professionalize and strengthen the Quezon City workforce; and (14) listen to our citizens and know what they need;

WHEREAS, it is imperative to revise the City's Comprehensive Development Plan to align the City's development vision, sectoral goals, objectives, strategies and policies with the local executive and legislative agenda, and regional, national and global development vision and goals;
