WHEREAS, under the Local Government Code of 1991 specifically Section 36. Assistance to People's and Non-Governmental Organizations – a local government unit may, through its local chief executive and with the concurrence of the Sanggunian concerned, provide assistance, financial or otherwise, to such people's and nongovernmental organizations for economic, socially-oriented, environmental, or cultural projects to be implemented within its territorial jurisdiction;

WHEREAS, the Visioncapture Media (registered as Frank David Fabros Mediaworks), engaged in the production of films and videos of cultural significances and popular appeal, drawing from the work of a pool of professional writers;

WHEREAS, Juan Novicio Luna, a Filipino National Artist was a painter, sculptor and a political activist of the Philippine Revolution during the 19<sup>th</sup> century. He became one of the first recognized Philippine artists;

WHEREAS, the Visioncapture Media will be embarking on a full-length film project, on the story of the Legendary National Artist Juan Novicio Luna;

WHEREAS, it is a form of good governance to utilize the resources and/or funds of the City as efficiently and effectively as possible to finance the delivery of basic services, and the enhancement of various social and economic activities for the prosperity and progress of the people of the City;


WHEREAS, Honorable Herbert M. Baustista, in his capacity as Mayor, acceded to assist in every means necessary by donating the amount of One Million (PhP1,000,000.00) to the Visioncapture Media for the creation and success of the film "Luna Y Salvacion" ("Ang Aking Juan Luna");

WHEREAS, the donation of the said amount is necessary to promote and provide support to similar outfits in order to inspire other Filipinos.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it hereby authorize the Quezon City Government through Mayor Herbert M. Bautista, to grant financial assistance in the amount of One Million Pesos (PHP1,000,000.00), in support of the Visioncapture Media for the film "Luna Y Salvacion" ("Ang Aking Juan Luna"), subject to existing Laws, Rules and Regulations.
