A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH MAYOR HERBERT M. BAUTISTA, TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF TEN MILLION PESOS (PHP10,000,000.00), IN SUPPORT OF THE 65<sup>TH</sup> MISS UNIVERSE PAGEANT IN FAVOR OF THE DEPARTMENT OF TOURISM, SUBJECT TO EXISTING LAWS, RULES AND REGULATION.

WHEREAS, the Miss Universe Pageant will bring international prestige, honor, publicity, goodwill and economic benefit for our country and its citizens;


WHEREAS, the event was a great opportunity for the Philippines to showcase its natural attractions, modern infrastructure facilities and with warmth of the Filipino people;

WHEREAS, a request was made by the Department of Tourism through Secretary Wanda Corazon Tulfo - Teo requesting for assistance/sponsorship for the said event;

WHEREAS, it is a form of good governance to utilize the resources and/or funds of the City as efficiently and effectively as possible to finance the delivery of basic services, and the enhancement of various social and economic activities for the prosperity and progress of the people of the City;

WHEREAS, Honorable Herbert M. Bautista, in his capacity as Mayor, acceded to assist the Department of Tourism for the 65<sup>th</sup> Miss Universe Pageant held in the Philippines;

WHEREAS, the donation of the said amount is necessary to promote and provide support to similar outfits in order to inspire other people. /


NOW, THEREFORE,
