Authority to Negotiate and Secure Grants - Local chief executives may, upon authority of the Sanggunian, negotiate and secure financial grants or donations in kind, in support of the basic services of facilities enumerated under Section 17 hereof, from local and foreign assistance agencies without necessity of securing clearance or approval therefore from any department, agency, or office of the national government or from any higher local government unit, xxx;

WHEREAS, the Organisasyon ng Pilipinong Mangaawit (OPM), a non-stock, non-profit association is the leading and most respected organization of the Filipino singers in the country, established on 27, October 1986, advocating the rights, welfare and support for the Filipino singers; y

WHEREAS, a request was made by the Organisasyon ng Pilipinong Mangaawit (OPM) for financial assistance/promotional partnership for the funding and shall be utilized by the OPM Programs and operational costs from January 2017 to December 2017 for the OPM's Programs, singers' welfare and hospitalization benefits and operational costs;

WHEREAS, it is a form of good governance to utilize the resources and/or funds of the City as efficiently and effectively as possible to finance the delivery of basic services, and the enhancement of various social and economic activities for the prosperity and progress of the people of the City;


WHEREAS, Honorable Herbert M. Bautista, in his capacity as Mayor, acceded to assist the cast and the Organisasyon ng Pilipinong Mangaawit (OPM), in every means necessary by donating the amount of One Million Pesos (Php1,000,000.00) for the success of the OPM's objective and projects;

WHEREAS, the donation of the said amount is necessary to promote and provide support to similar outfits in order to inspire other people.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Quezon City Government, through Mayor Herbert M. Bautista, to grant financial assistance in the amount of One Million Pesos (PHP1,000,000.00), in support of the Organisasyon ng Pilipinong Mangaawit (OPM), subject to existing laws, rules and regulations.
