Francisco, Inc. hereby donates and conveys in favor of the Quezon City Government, one (1) open space covered by TCT No. 266283, five (5) road lots covered by TCT No. 26682 and four (4) easements covered by TCT No. 26684 of the Registry of Deeds of Quezon City;

WHEREAS, G.B Francisco Inc. hereby transfers, cedes and conveys by way of this Deed of Donation and Acceptance in favor of the Quezon City Government, all the rights, interest and title of the said parcel of land, free from all liens and encumbrances.
