A RESOLUTION URGING THE QUEZON CITY GOVERNMENT TO INCLUDE THE SIX HUNDRED TWENTY NINE SQUARE METERS AND TWENTY DECIMETERS (629.20) PROPERTY, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 40756 DESCRIBED AS LOT 3 BLOCK 6 NO. 117 CORREGIDOR STREET, GARCIA HEIGHTS, BARANGAY HOLY SPIRIT, QUEZON CITY, AS AREA OF PRIORITY DEVELOPMENT, IN THE INTEREST OF THE RESIDENTS THEREAT.

WHEREAS, the members of the Bahay Pangarap Homeowners Association, Inc. are the present occupants of the said parcel of land and are willing to purchase the same through Community Mortgage Program.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the Quezon City Government to include the Six Hundred Twenty Nine Square Meters and Twenty Decimeters (629.20) property, covered by Transfer Certificate of Title No. 40756 described as Lot 3 Block 6 No. 117 Corregidor Street, Garcia Heights, Barangay Holy Spirit, Quezon City, as Area of Priority Development in the interest of the existing residents thereat.
