WHEREAS, under the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Council, through a Resolution, may grant Special Permit or license;




WHEREAS, the authority to operate an Electronic Bingo Boutique granted herein shall be subject to the following limitations:

- a. The holding of Bingo games shall be in accordance with the Rules and Regulations promulgated by PAGCOR;
- b. The operation of Bingo Center/Hall shall not include the playing of games not related to or other than bingo;
- c. The operator is enjoined to prohibit individuals below 18 years of age from playing in the abovementioned games.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN A REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant a Special Permit to Mr. Romeo Chong for the operation of a PAGCOR-Licensed-E-Bingo Game at Fairview Terraces, Ayala Mall, Barangay Pasong Putik, Novaliches, Quezon City, for purposes of holding Bingo games subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation.

RESOLVED, FURTHER, that PAGCOR-Licensed E-Bingo Game shall remit to the City Treasurer a Franchise Fee of three percent (3%) of the gross sales of herein grantee, which shall be made payable yearly to the City Treasurer during the lifetime of this measure. ♪




