A RESOLUTION COMMENDING POLICE OFFICER 2 JOSELITO LANTANO OF POLICE SECURITY PROTECTION GROUP, PHILIPPINE NATIONAL POLICE, FOR SUCCESSFULLY QUELLING THE BUS ROBBERY INCIDENT THAT TOOK PLACE ON APRIL 4, 2017 ALONG EPIFANIO DELOS SANTOS AVENUE (EDSA), QUEZON CITY.

WHEREAS, on April 4, 2017, at about 2:15 a.m., a Diamond Star Bus bound for Malanday, Valenzuela City was robbed by a group of robbers in front of Nepa Q-Mart, along EDSA, Quezon City;

WHEREAS, one of the passengers of the said bus was Police Officer 2 Joselito Lantano, who was then off-duty and wearing civilian clothes;

WHEREAS, unmindful of his personal safety, PO2 Lantano reacted properly to quell the robbery incident and to ensure the protection of other bus passengers; x
