*WHEREAS, the Quezon City Government supports the judicial system of the Philippines, where the Regional Trial Courts and Metropolitan Trial Courts are housed within the Quezon City Hall complex;*

*WHEREAS, in support of the outreach program of the Judiciary wherein trial courts are made accessible to the public, the Quezon City Government through Mayor Herbert M. Bautista, has recently procured and issued one (1) unit of Hino Bus converted into a Justice on Wheels complete with all accessories essential to a hearing room, to the Quezon City-Regional Trial Courts;*

*WHEREAS, the Justice on Wheels (Hino Bus Chassis Mounted With Mobile Court Body) shall be utilized by the QC-RTC to provide mobile trial courts within Quezon City;*

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to donate one (1) unit of Justice on Wheels (Hino Bus Chassis Mounted with Mobile Court Body) to QC-RTC and to turn-over all the documents pertaining to its ownership.

RESOLVED, FURTHER, that ownership of the Justice on Wheels be transferred to QC-RTC through a Deed of Donation to be signed by the City Mayor, Herbert M. Bautista as DONOR, Chief Justice Ma. Lourdes P.A. Sereno as DONEE, Aldrin C. Cuña, City Administrator and Cecilyn B. Villavert, Executive Judge, QC-RTC as Witnesses.


