A RESOLUTION RATIFYING THE DEED OF DONATION ENTERED INTO BY THE QUEZON CITY GOVERNMENT, REPRESENTED BY THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, AND COUNCILOR ROGELIO "Roger" P. JUAN DONATING THIRTY FOUR (34) UNITS OF MOTORCYCLES IN FAVOR OF DISTRICT VI BARANGAYS REPRESENTED BY EACH BARANGAY CHAIRMAN AND TO TRANSFER THE OWNERSHIP THEREOF SOLELY FOR THE PURPOSE OF MANAGEMENT.

NOW, THEREFORE,

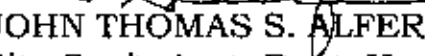
BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to ratify, as it does hereby ratify the Deed of Donation entered into by the Quezon City Government, represented by the City Mayor, Honorable Herbert M. Bautista, and Councilor Rogelio "Roger" P. Juan donating Thirty Four (34) units of motorcycles in favor of District VI barangays represented by each Barangay Chairman and to transfer the ownership thereof solely for the purpose of management. ✓

RESOLVED, FURTHER, that the ownership of the said vehicles be transferred to the recipients through the Deed of Donation duly signed by Honorable Herbert M. Bautista and Honorable Rogelio "Roger" P. Juan as Donors, and the respective Punong Barangays of all barangays of District 6, Quezon City as Donee, with the Head of the City General Services Department (CGSD) as witness.

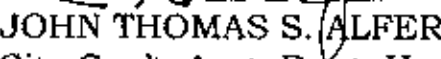
