RESOLUTION NO. SP. 7140 , S-2017

A RESOLUTION CONGRATULATING AND COMMENDING THE QUEZON CITY POLICE DISTRICT (QCPD) HEADED BY POLICE CHIEF SUPERINTENDENT GUILLERMO LORENZO T. ELEAZAR AND THE JOINT OPERATIVES OF THE DISTRICT SPECIAL OPERATIONS UNIT (DSOU) UNDER PSUPT. ROGARTH B. CAMPO, DISTRICT INTELLIGENCE DIVISION (DID), TALIPAPA POLICE STATION LED BY PSUPT. DANILO MENDOZA AND AFP COUNTERPARTS FOR THE ARREST OF A SUSPECTED MEMBER OF THE MAUTE TERRORIST GROUP AT THE SALAM COMPOUND, BARANGAY CULIAT, QUEZON CITY.

WHEREAS, police officers undoubtedly perform the important but risky task of ensuring the safety of the citizens and maintaining peace and order in the community;

WHEREAS, at about 9:15 p.m. of March 20, 2017, joint personnel of DSOU, DID, Police Station 3 and AFP counterpart arrested a suspected member of the Maute Terrorist Group who is allegedly involved in a foiled bombing attempt on November 28, 2016 near the US Embassy in Manila;

WHEREAS, PCSupt. Eleazar identified the suspected Maute terrorist as Nasip Ibrahim Y. Sarip, 35 years old, native of Marawi City, residing at No. 31 A Libyan Street, Salam Compound, Barangay Culiat, Quezon City and was arrested for violation of Presidential Decree No. 1866, as amended by Republic Act No. 10591 (Comprehensive Firearms and Ammunition Regulation Act), Republic Act No. 9516 (Unlawful Possession of Explosives), Violation of Republic Act No. 9165 (Comprehensive Dangerous Drugs Act of 2002) and Obstruction of Justice;

WHEREAS, police said Ibrahim was nabbed from his home in Salam Compound in Barangay Culiat in Quezon City on the said day providing "safe haven" to other members of the group;

WHEREAS, this discovery lead to the belief that the Maute Group has already established presence in Metro Manila and as to what extent – that is the subject of the PNP follow-up investigation and operation, adding that the group is the "strongest" among local terror groups who have pledged allegiance to the ISIS, according to the PNP;

WHEREAS, the Maute group first made headlines after its members were accused of planting the bomb that killed 15 people and wounded dozens in a night market in Davao City on September 2, 2016;

WHEREAS, the operations conducted by the PNP and AFP units at the national level, with the QCPD maintaining constant coordination when suspects are identified to be in Quezon City, has provided sufficient personnel to back up the national intelligence units for successful apprehension. The arrest was made with the help and cooperation of Barangay Culiat officials led by Punong Barangay Vic Bernardo, the residents and Muslim tribal leaders in Salam Compound in support to the QCPD's anti-criminality and anti-terrorism program;

WHEREAS, it is just and proper to give the sincerest congratulations and commendation to these courageous officers, for the immediate action they have shown in responding to a crime.
