*WHEREAS, fuel stations are among the uses that require Special Use Permit upon authorization from the Quezon City Council pursuant to Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance, as amended;*

WHEREAS, the construction and operation of a gas station will provide employment and promote economic development in the city.


NOW, THEREFORE,


