RESOLUTION NO. SP. 7148 _, S-2017

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO SPOUSES ROLANDO B. MAGCALE AND FLORDELIZA C. MAGCALE FOR THE CONSTRUCTION OF A TWO (2)-STOREY COMMERCIAL, AND OFFICE BUILDING LOCATED AT LOTS 2 AND 3, BLOCK 1, PHASE 1, OMEGA STREET, CIUDAD VERDE EXECUTIVE VILLAGE, BARANGAY FAIRVIEW, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF QUEZON CITY COMPREHENSIVE ORDINANCE NO. SP-918, S-2000, AS AMENDED.
