A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO DONATE TEN (10) UNITS OF DESKTOP COMPUTERS, TWO (2) UNITS OF LAPTOP COMPUTERS AND THREE (3) UNITS OF INKJET PRINTERS TO BARANGAY HOLY SPIRIT, THIS CITY AND TO TRANSFER THE OWNERSHIP OF SAID ITEMS TO THE SAID RECIPIENT WITHOUT COST.
