A RESOLUTION URGING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO DIRECT THE CITY ENGINEERING DEPARTMENT TO CAUSE THE REPAIR AND MAINTENANCE OF THE ROAD LOTS AND OPEN SPACES OF BERNARTY SUBDIVISION IN BARANGAY BAGBAG, QUEZON CITY, PURSUANT TO THE PROVISIONS OF CITY ORDINANCE NO. SP-2298, S-2014, WHICH WERE ABANDONED BY THE SUBDIVISION DEVELOPER.

WHEREAS, the developer had abandoned Bernarty Subdivision and failed to turn-over the road lots and open spaces therein to the Quezon City Government;

WHEREAS, Ordinance No. SP-2298, S-2014 declared abandoned roads, alleys, open spaces and excess lots in all subdivisions in Quezon City as properties for public use by the City Government, thereby setting the guidelines for the use thereof and for other purposes. ✧


NOW, THEREFORE,
