RT-45696 (74649) LOCATED AT LOT 13 BLOCK 6 LUPANG PANGAKO, BARANGAY PAYATAS, QUEZON CITY, AS AREA FOR PRIORITY DEVELOPMENT, IN THE INTEREST OF THE RESIDENTS THEREAT.
