A RESOLUTION DECLARING THE ABANDONED ROADS, ALLEYS, OPEN SPACES AND EXCESS LOTS OF GLORIA III SUBDIVISION LOCATED AT BARANGAY CULIAT, THIS CITY, AS PROPERTIES FOR PUBLIC USE OF THE QUEZON CITY GOVERNMENT, PURSUANT TO ORDINANCE NO. SP-2298, S-2014.

WHEREAS, Gloria III Subdivision, a residential subdivision located at Harangay Culiat, Quezon City, owned and developed by Saf Associates Realty and Builders Corporation with SEC Registration No. 0000063521204 and an approved Subdivision Plan Psd-00-065464;

WHEREAS, based on the certifications issued by the Securities and Exchange Commission, the developer Saf Associates Realty and Builders Corporation has been in inactive status;

WHEREAS, there was an attempt in the past to donate the road lots and open spaces but it did not materialize, for unknown reasons. Likewise, the inaction of the developer to donate said open spaces and road lots as provided in Presidential Decree No. 1216 and the efforts of the homeowner's association to locate the developer proved to be futile;

WHEREAS, the Subdivision Administration Unit (SAU) of the City Planning and Development Office has interposed no objection for the declaration of the same as abandoned property;

WHEREAS, Ordinance No. SP-2298, S-2014 emphasized that the dissolution or cessation to exist of developers, owners and operators that have not turned over such open spaces to the city shall not preclude the City Government from maintaining, preserving and developing the same for the benefit of the public;

WHEREAS, Gloria III Subdivision located at Barangay Culiat, Quezon City, has been abandoned and during these past many years, the administration and utilization of the subdivision's facilities and road lots were undertaken by the homeowners.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to declare, as it does hereby declare the abandoned roads, alleys, open spaces and excess lots of Gloria III Subdivision located at Barangay Culiat, this city, as properties for public use of the Quezon City Government, pursuant to Ordinance No. SP-2298, S-2014.
