WHEREAS, to accelerate the delivery of basic services and to speed up the mobility of personnel, the Office of Councilor Marra C. Suntay needs service and monitoring vehicles;

WHEREAS, Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", provides that "the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance;

WHEREAS, the Technical Specifications of the said motor vehicles are as follows:

Load Capacity: 770kg; 185 R14 tires and 14" steel rims; 12 seating capacity; Fuel tank capacity 46 liters; Cargo bed dimensions 2,200mm x 1585mm. Rear body dimension, Length 2,234mm, width 1,680mm, height 1,759mm. With dual airbag and graphic sticker.




