RESOLUTION NO. SP. 7212, S-2017

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO MR. JEROME C. BANGAYAN FOR THE CONSTRUCTION OF A TWO (2) STOREY RESIDENTIAL / COMMERCIAL BUILDING LOCATED AT LOT 5-A, BLOCK 35, ILANG-ILANG CORNER SAMPAGUITA STREETS, MALIGAYA PARK SUBDIVISION, BARANGAY PASONG PUTIK PROPER, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE.

WHEREAS, the City Council is empowered under the Local Government Code of 1991 to issue Certificate of Exception in consonance with the enacted Quezon City Comprehensive Zoning Ordinance, subject to classification and zoning;

WHEREAS, Mr. Jerome C. Bangayan, owner of the property, is applying for a Certificate of Exception for the construction of a Two (2) Storey Residential/Commercial Building located at Lot 5-A, Block 35 Ilang-ilang corner Sampaguita Streets, Maligaya Park Subdivision, Barangay Pasong Putik Proper, Quezon City;

WHEREAS, however, the zone classification falls on the Medium Density Residential Zone (R-2), such that the project activity exceeds the allowable commercial area in R-2 zone, only 30% of the total floor area is allowable; \downarrow

WHEREAS, the Sangguniang Barangay of Barangay Pasong Putik Proper interposes no objection to the said project;

WHEREAS, the said project will not adversely affect public health, safety and welfare and is in keeping with the general pattern of development in the community;

WHEREAS, the applicant has complied with and is further ready, able and willing to comply with all the prescribed requirements relative thereto, pursuant to and in keeping with the Quezon City Comprehensive Zoning Ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Certificate of Exception to Mr. Jerome C. Bangayan, for the construction of a Two (2)-Storey Residential/Commercial Building located at Lot 5-A, Block 35, Ilang-ilang corner Sampaguita Streets, Barangay Pasong Putik Proper, Quezon City, allowing deviation from the restrictions of the Quezon City Comprehensive Zoning Ordinance.
