WHEREAS, the Quezon City Government is a local government unit organized and existing by virtue of the laws of the Republic of the Philippines, with principal office and postal address at Quezon City Hall, Elliptical Road, Barangay Central, 1100, represented by its City Mayor, Honorable Herbert M. WHEREAS, the Quezon City Government is the administrator of a parcel of land with an approximate area of twenty six (26) hectares known as the Quezon Memorial Circle and accepted to use the portion thereof for the construction of restaurants, food stalls and plant stalls under the terms and conditions acceptable to both parties;

WHEREAS, the Quezon City Government has already undertaken the further development including the actual administration, management and over-all maintenance of the Quezon Memorial Circle;

WHEREAS, Section 455 (b) (1) (vi) of the same Code provides that the City Mayor shall represent the City in all its business transactions and sign in its behalf contracts and agreements upon authority of the Sangguniang Panlungsod;

WHEREAS, the parties has signed the Memoranda of Agreement (MOA) subject to the terms and conditions set forth therein.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF THE QUEZON CITY IN REGULAR SESSION ASSEMBLED, to ratify, as it does hereby ratify the Memorandum of Agreement entered into by and between the Quezon City Government, represented by the City Mayor, Honorable Herbert M. 
