RESOLUTION NO. SP. 7245, S-2017

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO BENBY ENTERPRISES, INC. FOR THE CONSTRUCTION OF A SEVEN (7) STOREY COMMERCIAL/OFFICE BUILDING WITH BASEMENT PARKING AND ROOF DECK TO BE LOCATED AT LOT 4, BLOCK 404 BANAWE STREET, BARANGAY MANRESA, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-918, S-2000, OTHERWISE KNOWN AS THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE, AS AMENDED.

WHEREAS, Benby Enterprises, Inc., represented by Ms. Evelyn Yap, is applying for a Certificate of Exception for the construction of a Seven (7) Storey Commercial/Office Building with basement parking and roof deck to be located at Lot 4, Block 404 Banawe Street, Barangay Manresa, Quezon City, a classified Residential Zone as per evaluation made by the City Planning and Development Office;

WHEREAS, pursuant to the provisions of Articles IV, V, VI and VIII of Ordinance No. SP 918, S-2000, as amended, and its Implementing Rules and Regulations, an Exception is required for the aforesaid project upon authorization from the City Council;

WHEREAS, the proposed project will not adversely affect public health, safety, and welfare and is in keeping with the general pattern of development in the community;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Certificate of Exception to Benby Enterprises, Inc. for the construction of a Seven (7) Storey Commercial/Office Building with basement parking and roof deck to be located at Lot 4, Block 404 Banawe Street, Barangay Manresa, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance, as amended.
