RESOLUTION NO. SP- **7293**, S-2017

A RESOLUTION GRANTING THE RENEWAL OF THE SPECIAL PERMIT OF B-7 AMUSEMENTS CORPORATION TO OPERATE A CONVENTIONAL AND ELECTRONIC BINGO GAMES IN CIRCLE C MALL LOCATED IN CONGRESSIONAL AVENUE CORNER JUPITER STREET, BARANGAY BAHAY TORO, QUEZON CITY SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, B-7 Amusements Corporation, a domestic corporation duly organized and existing under and by virtue of Philippine laws, represented by its President, Engr. Manuel M. De Los Santos, Jr., is applying for the renewal of its Special Permit to operate a Conventional and Electronic Bingo Games located in Circle C Mall in Congressional Avenue corner Jupiter Street, Barangay Bahay Toro, Quezon City;

WHEREAS, the Quezon City Council previously passed Resolution No. SP-4498, S-2009 granting a Special Permit to the applicant to operate the said Electronic Bingo;

WHEREAS, in its letter dated May 15, 2017 addressed to the Members of the City Council, the applicant has signified its intention to renew their Special Permit;

WHEREAS, to enable B-7 Amusements Corporation to continue its legal business operation, there is a need to renew their Special Permit;



WHEREAS, the aforesaid business activity will provide employment and additional revenue to the city government, thereby boosting the city's economy for the welfare of its inhabitants.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew the Special Permit of B-7 Amusements Corporation, represented by Engr. Manuel M. De Los Santos, Jr., to operate a Conventional and Electronic Bingo Games in Circle C Mall located in Congressional Avenue corner Jupiter Street, Barangay Bahay Toro, Quezon City, subject to the Rules and Regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED, FURTHER, that the authority to operate Conventional and Electronic Bingo Games granted herein shall be subject to the following conditions:


- a. The holding of Conventional and Electronic Bingo Games shall be in accordance with the Rules and Regulations promulgated by PAGCOR;
 - b. The operation of Electronic Bingo Games shall not include the playing of games not related to or other than bingo;
 - c. The operator is enjoined to prohibit individuals below eighteen (18) years of age from playing in the above-mentioned games; and
 - d. The operator shall secure the necessary Business/Mayor's Permit for its operation and shall remit to the City Treasurer's Office the corresponding franchise fee in accordance with the Quezon City Revenue Code and pertinent laws.




