RESOLUTION NO. SP 7294, S-2017

A RESOLUTION RENEWING THE SPECIAL PERMIT OF THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION TO OPERATE AN INTERNET CASINO THROUGH AN ACCREDITED INTERNET OPERATOR, B-7 AMUSEMENTS CORPORATION, REPRESENTED BY ENGR. MANUEL M. DE LOS SANTOS, JR., IN BERKELEY SQUARE MALL LOCATED IN COMMONWEALTH AVENUE, BARANGAY OLD BALARA, QUEZON CITY SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, B-7 Amusements Corporation, a domestic corporation duly organized and existing under and by virtue of Philippine laws, represented by Engr. Manuel M. De Los Santos, Jr., is applying for the renewal of the required Special Permit to operate an Internet Casino in Berkeley Square located in Commonwealth Avenue, Barangay Old Balara, Quezon City;

WHEREAS, the Quezon City Council previously passed a Resolution granting the Philippine Amusement and Gaming Corporation (PAGCOR) a Special Permit to operate an Internet Casino Station (ICS) through an accredited internet operator, B-7 Amusements Corporation;

WHEREAS, to enable B-7 Amusements Corporation to continue its legal business operation, there is a need to renew the subject Special Permit;

WHEREAS, in its letter dated May 15, 2017 addressed to the Members of the City Council, the applicant has signified its intention to renew the subject Special Permit;


WHEREAS, the aforesaid business activity will provide employment and additional revenue to the city government, thereby boosting the city's economy for the welfare of its inhabitants.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew the Special Permit issued in favor of The Philippine Amusement and Gaming Corporation (PAGCOR) to operate an Internet Casino through an accredited Internet Operator, B-7 Amusements Corporation represented by Engr. Manuel M. De Los Santos, Jr., in Berkeley Square Mall located in Commonwealth Avenue, Barangay Old Balara, Quezon City, subject to the Rules and Regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED, FURTHER, that the authority to operate Internet Casino granted herein shall be subject to the following conditions:

- a. The holding of Internet Casino shall be in accordance with the Rules and Regulations promulgated by PAGCOR;
- b. The operation of Internet Casino shall not include the playing of games not related to internet casino; *




- c. *The operator is enjoined to prohibit individuals below eighteen (18) years of age from playing in the above-mentioned games;*


- d. *The operator/applicant shall remit a franchise fee of three percent (3%) of the gross revenue of herein grantee, which shall be made payable to the City Treasurer's Office during the lifetime of the measure.*

RESOLVED, FINALLY, that this Special Permit to operate/conduct Internet Casino shall be valid for a period of two (2) years from the approval of this Resolution and may be renewed by the City Council.
