A RESOLUTION AUTHORIZAGE STATE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, QUELLOW CITY, TO EXTEND FINANCIAL ASSISTANCE OF FIVE THOUSE AND PRISOS (PHP5,000.00) TO EACH OF THE TWO THOUSAND SEVERY HUNDRED SIX (2,706) INFORMAL SETTLER FAMILIES (ISFS), WHO WILL BE AFFECTED BY THE PROPOSED CONSTRUCTION OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWII) RETARDING POND AND HOUSING PROJECT TO BE BUILT BY AGUI-QC ON TOP OF SAID POND, LOCATED IN KAINGIN BUKID BARANGAY APOLONIO SAMSON, QUEZON CITY, AND WHO ARE ABOUT TO BE TEMPORARILY TORELOCATED NATION:... HOUSING AUTHORITY RESETTLEMENT SITES, SO AS TO GIVE WAY TO IMPLEMENTATION OF SAID PROJECTS, EQUIVALENT TO A TOTAL THIRTEEN MILLION FIVE HUNDRED THIRTY AMOUNT OF THOUSAND PESOS (PHP13, 530, 000.00).

WHEREAS, an on-site nousing project under the concept of People's Plan was proposed und agreed to be implemented in the fire affected area of Kaingin Bukia, Barangay Apolonio Samson, Quezon City, which housing project, comprising of 12 contiguous parcels of land and with a gross area of more or less 24,603 square meters, shall benefit the on-site informal scattler families;

WHEREAS, in as much his the proposed project site is lowlying and flood prone, the holding project shall be designed and planned to be built on top a retarding pond, which retarding pond, according to the Department of Public Works and Highways (DPWH), will eventually reduce the flooding in the vicinity and in the area of Araneta Avenue;

WHEREAS, by virtue of a memorandum of Agreement (MOA) entered into by and between the Quezon City Government (LGU-QC) and the Department of the Interior and Local Government (DILG), a financial support assistance from the MMRB ISFs Fund of the DILG amounting to Php Local Million was transferred to LGU-QC, which fund is specifically interacted for the construction of the housing component of the proposed housing project in Kaingin Bukid;

WHEREAS, to implement the aforementioned projects, there is a need to clear the project size of ISFs structures and other obstruction through temporary as well as permanent relocation of on-site ISFs, which number of ISFs according to survey comprises of 1,385 house owners (HO), WE snarers (S) and 743 renters (R) or a total of 2,706 families;

WHEREAS, to draw cooperation from the affected ISFs and also to provide them with something to start with at the resettlement site, there is a need for the Quezon City Government to allocate and extend financial assistance fund to the 2,706 affected ISFs, in the total amount of Php13,530,000.00 or an equivalent amount of Php5,000.00 per affected ISFs;

WHEREAS, pursuant to section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as "the Local Government Code of 1991", the City Mayor shall represent the City in all its business transactions and sign in us benulf all bonds, contracts and obligations, and such other accuments upon the authority of the Sangguniang Panlungsod or parsuant to law or ordinance.

BE IT RESOLVED BY THE COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMB...... a authorize, as it does hereby authorize the City Mayor, Homoraville Herbert M. Bautista, Quezon City, to extend financial adsistance of Five Thousand Pesos (Php5,000.00) to each of the Low Thousand Seven Hundred Six (2,706) informal settler families  $\mu SFs_b$  who will be affected by the proposed construction of the Department of Public Works and Highways (DPWH) retarding point and nousing project to be built by the Quezon City Government on top of said pond, located in Kaingin Bukid, Barangay Apolonio Samson. Quezon City, and who are about to be temporarily and permanently relocated to National Housing Authority (NHA) resettlement sites, so as to give way to the implementation of said projects, equivalent to a total amount of Thirteen Million Five Hunared Thirty Thousand (Php13,530,000.00).
