A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO SIGN AND ACCEPT THE DEED OF DONATION AND ACCEPTANCE IN BEHALF OF THE QUEZON CITY GOVERNMENT WITH VICTORIA REALTY CO. INC., REPRESENTED BY ITS PRESIDENT RUBEN M. TIOSEJO, CONSISTING OF SIX (6) ROAD LOTS, TWO (2) EASEMENTS AND ONE (1) OPEN SPACE LOCATED AT VICTORIA SUBDIVISION, BARANGAY SAUYO, QUEZON CITY.
