RESOLUTION NO. 20-A-129 Series of 2020

AWARDING THE CONTRACT FOR THE ACQUISITION OF GOODS AND SERVICES THROUGH ALTERNATIVE METHOD OF PROCUREMENT

WHEREAS, in its Resolution No. **02-15**, Series of 2020 duly approved by the City Mayor, the Bids and Awards Committee on Goods and Services (the "Committee") recommended the use of negotiated mode as an alternative method of procurement pursuant to **Section 53.9** of the Revised Implementing Rules and Regulations of RA 9184, which pertinently provides that negotiated procurement may be resorted to where the procurement does not fall under Shopping in Section 52.1 (b) of the RIRR and the amount does not exceed P1,000,000.00; and
