A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO PURCHASE EIGHTEEN (18) UNITS OF RISOGRAPH MACHINES (DUPLICATING MACHINE), FORTY (40) UNITS OF TELEVISION SET AND FORTY (40) UNITS OF DVD PLAYER TO BE DONATED TO PUBLIC DAY CARE CENTERS, TWELVE (12) PUBLIC ELEMENTARY SCHOOLS AND SIX (6) PUBLIC HIGH SCHOOLS IN DISTRICT VI, QUEZON CITY.

WHEREAS, these educational institutions are short-handed in such equipment to further enhance and improve the educational programs conducted therein, thereby posing an obstacle to the effectiveness and efficiency of said educational programs;

WHEREAS, it is shared and commonly desired with the Office of City Councilor Marivic Co Pilar and by the Local Government of Quezon City that this equipment be provided to these educational institutions;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Quezon City Government, through the City Mayor, Honorable Ma. Josefina G. Belmonte, to purchase eighteen (18) units of risograph machines (duplicating machine), forty (40) units of television set and forty (40) units of DVD player to be donated to public day care centers, twelve (12) public elementary schools and six (6) public high schools in District VI, Quezon City.
