RESOLUTION NO. SP- 8709, S-2021

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO EXECUTE AND SIGN THE DEED OF DONATION AND ACCEPTANCE WITH THE PHILIPPINE CHAMBER OF COMMERCE-QUEZON CITY (PCCI-QC) IN THE AMOUNT OF THIRTEEN MILLION PESOS (PHP13,000,000.00) TO AUGMENT THE MEDICAL PERSONNEL REQUIREMENT OF THE QUEZON CITY GOVERNMENT FOR THE PURPOSE OF FURTHER EXPANDING THE COVID-19 VACCINATION PROGRAM IN QUEZON CITY.

WHEREAS, it is the policy of the local government of Quezon City to extend partnership and cooperation with humanitarian organizations and private entities in addressing health issues which affect its constituents;

WHEREAS, the Quezon City Government is committed to collaborate with various stakeholders in its efforts to prevent, mitigate, and contain the spread of COVID-19 within its territorial jurisdiction;

WHEREAS, on April 7, 2020, the Quezon City Council has passed Resolution No. SP-8170, S-2020, entitled: "A Resolution Authorizing the City Mayor, Honorable Ma. Josefina G. Belmonte, to Accept the Donation of the Philippine Chamber of Commerce and Industry-Quezon City (PCCI-QC) in the amount of Fifty Million Pesos (Php50,000,000.00) for the Purchase and Distribution of Personal Protective Equipment (PPE) for Medical Frontliners, Testing Kits and Other Medical Supplies and Equipment to Suppress the Coronavirus Disease 2019 (COVID-19) Pandemic in Quezon City;

WHEREAS, on August 3, 2020, the Quezon City Council has passed Resolution No. SP-8249, S-2020, entitled: "A Resolution Authorizing the City Mayor, Honorable Ma. Josefina G. Belmonte, to Accept the Donation of the Philippine Chamber of Commerce and Industry-Quezon City (PCCI-QC) in the amount of Eighteen Million Pesos (Php18,000,000.00) for the Purchase of six (6) Testing Booths, Washable and Reusable Face Masks for Children and for Operational Expenses of the Hospital on Wheels for a Period of Three (3) Months, for the Benefit of the Residents of Quezon City;

WHEREAS, all these amounts were originally collected from the registered businesses in Quezon City pursuant to Ordinance No. SP-1429, S-2004, as amended by Ordinance No. SP-2035, S-2010, otherwise known as the "Quezon City Data Registry Databank";

WHEREAS, PCCI-QC has launched the "Support Project Donation for the COVID-19 Vaccination Drive of the Quezon City Local Government" where it donated the amount of Thirteen Million Pesos (Php13,000,000.00) in favor of the Quezon City Government pursuant to its duly adopted and approved Board Resolution No. 008-2021, dated May 17, 2021;

WHEREAS, pursuant to Board Resolution No. 008-2021, the donated amount of Thirteen Million Pesos (Php13,000,000.00) shall be utilized to augment the medical personnel requirement of the Quezon City Government for the purpose of ramping up its inoculation, particularly to those belonging but not limited to the A4 priority list;

WHEREAS, the medical personnel shall be assigned to the vaccination sites determined by the Quezon City Government and each vaccination site shall have an ample number of doctors, nurses and paramedical attendants commensurate to the target number of vaccines to be administered;

WHEREAS, the parties herein stipulated the terms and conditions of their arrangements on the "Support Project Donation for the COVID-19 Vaccination Drive of the Quezon City Local Government" Program for the benefit of the Quezon City residents;

WHEREAS, the generosity of the officers and members of PCCI-QC during this time of COVID-19 pandemic is greatly appreciated by the Quezon City Government;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.
