RESOLUTION NO. SP- **8781**, S-2021

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF TEN MILLION PESOS (PHP10,000,000.00), IN FAVOR OF THE FIFTY (50) MEMBERS OF THE QUEZON CITY COUNCIL OF SECTORAL REPRESENTATIVES (QC-CSR), SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, the Quezon City Council of Sectoral Representatives (QC-CSR) has always involved itself and take part in the formulation of policies and programs of the city and independently conducts and initiates its own programs for the benefit of all accredited organizations, associations, NGOs and POs in Quezon City;

WHEREAS, there are presently fifty (50) members of the QC-CSR, like in the past several years, and each member has a duty to coordinate the City's policies to its member-sectors, consolidate recommendations from accredited organizations for policy-making and serves as one of the links of the Quezon City Government to all sectors;

WHEREAS, the members of the QC-CSR has submitted their project proposals for the utilization of the Ten Million Pesos (Php10,000,000.00) total grant from the Quezon City Government to the members of the Quezon City Council of Sectoral Representatives;

WHEREAS, the Quezon City Government will be granting an amount of Two Hundred Thousand Pesos (Php200,000.00) to each of the members of the QC-CSR to be utilized relative to their submitted project proposals;

WHEREAS, the members of the QC-CSR perform their duties to contribute to the success of the City's plans for its residents and do such without any compensation from the city, most members of whom belong to the marginalized sectors;

WHEREAS, pursuant to Section 36 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the local government units may, through its local chief executive and with the concurrence of the Sanggunian concerned, provide assistance, financial or otherwise, to such people's and non-governmental organizations for economic, socially-oriented, environmental, or cultural projects to be implemented within its territorial jurisdiction.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to grant financial assistance in the amount of Ten Million Pesos (Php10,000,000.00), in favor of the fifty (50) members of the Quezon City Council of Sectoral Representatives (QC-CSR), subject to existing laws, rules and regulations.
