BELMONTE, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE INTENDED FOR THE MONITORING AND IMPLEMENTATION OF THE PROJECTS AND PROGRAMS OF THE QUEZON CITY ANTI-DRUG ABUSE ADVISORY COUNCIL (QCADAAC), TO BE CHARGED AGAINST THE FUNDS OF THE SAID OFFICE.
