WHEREAS, on June 27, 2017 and July 10, 2017, the City Council approved and confirmed, respectively, Resolution No. SP-7120, S-2017, entitled: "A RESOLUTION AUTHORIZING THE CITY MAYOR OF QUEZON CITY, HONORABLE HERBERT M. BAUTISTA TO ENTER INTO A CONTRACT/AGREEMENT WITH THE WINNING SUPPLIER-BIDDER OF FIREARMS AND BULLET PROOF VEST FOR THE OFFICIAL USE OF THE QUEZON CITY POLICE DISTRICT (QCPD), IN CONNECTION WITH THE MAINTENANCE OF PEACE AND ORDER IN QUEZON CITY, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS."

WHEREAS, the Quezon City Council hereby authorizes the City Mayor, Honorable Herbert M. Bautista, to enter into a contract/agreement in behalf of the City Government, with the winning bidder, Gigi Industries, Inc. (TRUST TRADE) for the procurement of guns and magazines;

WHEREAS, there is a delay in the delivery of the Glock 17 Gen4 Caliber 9mm pistols due to failure to secure grant of export permit from the United States Government, as per advise by the aforementioned supplier;

WHEREAS, instead of Glock 17 Gen4 Caliber 9mm pistol the City Government has decided to purchase Taurus Caliber 40 from the same supplier.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to amend, as it does hereby amend Resolution No. SP-7120, S-2017, by changing the Item Description from Glock 17 9mm Gen4 to Taurus Caliber 40.
