A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH CONCENTRIX FOR THE IMPLEMENTATION OF THE ADOPT A COMMUNITY PROGRAM IN QUEZON CITY.

WHEREAS, the City Government, in its effort to address the food security concern of its constituents, has been promoting and spearheading the implementation of Urban Agriculture in its jurisdiction as one of the key components of its Food Security Program for the benefit primarily of the vulnerable and marginalized sectors of the City;

WHEREAS, pursuant to the City Government's Food Security Program, the City Mayor, Honorable Ma. Josefina G. Belmonte, signed Executive Order No. 32, Series of 2020 on 19 May 2020 creating the Task Force on Food Security;

WHEREAS, the City Government's Food Security Program specifically aims to address the issue of food availability and access of majority of its constituents to affordable and nutritious food by encouraging them to engage in urban gardening, providing them the necessary assistance and technology, and by utilizing and mobilizing available resources;

WHEREAS, it is the policy of the Quezon City Government to collaborate with parties who are willing to support its projects addressing livelihood and food security, and economic issue. Further, the QC Food Security Task Force identifies the lands that can be made productive and used to support the City's Grow QC - Kasama ka sa Pag-Unlad sa Pagkain, Kabuhayan, at Kalusugan 7-Point Action Plan to address hunger, loss of livelihood and better health as a recovery response to the pandemic;

WHEREAS, Concentrix has an "Adopt a Community Program" with the objective of adopting a community which can be its partner and primary beneficiary in its Corporate Social Responsibility programs which will make an impact for improvement and more sustainable future;

WHEREAS, Concentrix and the Quezon City Government, having a shared ideal of helping and supporting communities, partners together wherein Quezon City Government will provide a land located at Pingkian 3, Barangay Tandang Sora known as Sunnyville Community Model Farm, which will be farmed by beneficiaries through the resources provided by Concentrix, and ultimately intended to benefit at least forty (40) families;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.
