A RESOLUTION REQUESTING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO INCLUDE IN THE ANNUAL BUDGET OF THE QUEZON CITY GOVERNMENT FOR THE CALENDAR YEAR 2022 OR IN THE MOST CONVENIENT YEAR, THE ESTABLISHMENT OF THE QUEZON CITY "HOME FOR THE AGED AND HOSPICE" AS PROVIDED IN ORDINANCE NO. SP-2402, S-2015.

WHEREAS, the 17th Quezon City Council adopted Resolution No. SP-4511, S-2009 entitled "A Resolution urging the City Mayor, Honorable Feliciano R. Belmonte, Jr., to initiate the establishment of a Center for the Elderly (Home for the Aged) in an appropriate location within Quezon City and allocating the necessary amount for the purpose";
