RESOLUTION NO. SP- 8706 , S-2021

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A PUBLIC-PRIVATE PARTNERSHIP AGREEMENT WITH THE QUALIFIED PRIVATE SECTOR PROPONENT NECESSARY TO EFFECT THE IMPLEMENTATION OF THE FOOTBRIDGE DONATION, REDEVELOPMENT, MONITORING AND MAINTENANCE PROJECT FOR QUEZON CITY.

WHEREAS, Ordinance No. SP-2336, Series of 2014, otherwise known as the Quezon City Public-Private Partnership Code, was enacted consistent with the City Government's policy of advancing the public good and general welfare, and promoting the interest of the community and the City within the framework of sustainable and integrated development, and effective constructive engagement and meaningful people's participation in local governance;

WHEREAS, it shall be beneficial to construct new footbridges and rehabilitate existing footbridges to: (1) encourage the public to use footbridges in traversing roads; (2) lessen pedestrian-involved vehicular accidents; (3) ease the financial burden on the security and maintenance of footbridges; and (4) ease traffic flow;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Public-Private Partnership Agreement with the qualified private sector proponent necessary to effect the implementation of the footbridge donation, redevelopment, monitoring and maintenance project for Quezon City.

RESOLVED FURTHER, that the authority herein granted shall include the signing of ancillary contracts, provided that it is determined in the principal contract.

RESOLVED FINALLY, that a copy of the subject agreement shall form an integral part of this Resolution.
