## RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE METHOD OF PROCUREMENT FOR THE ACQUISITION OF GOODS AND SERVICES

WHEREAS, the submitted Purchase Requests with the following details:

WHEREAS, issued Proclamation No. 922 (Declaring a State of Public Health Emergency Throughout the Philippines) the above commodities which requires immediate procurement to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent, and appropriate response and measures in a timely manner to curtail and eliminate the COVID-19 threat;

WHEREAS, the proposed acquisition merits the application of Section 53.2 (Emergency Cases) (IRR of RA 9184) which provides that in case of imminent danger to life or property during a state of calamity, or when is of the essence arising from natural or man-made calamities or other causes where immediate action is necessary to prevent damage to or loss of life or property, or to restore vital public services, infrastructure facilities and other public utilities;

WHEREAS, the Bids and Awards Committee (BAC) – Good and Services, in its evaluation, considered all the factual circumstances of the foregoing and the immediate need for the acquisition of the goods and services which warrants and necessitates the use of alternative method of procurement through emergency to prevent loss of life as a result of the state of public health emergency throughout the Philippines;

**WHEREAS**, during the BAC Regular Meeting, the same has been resolved and immediately recommended to the HOPE for the procurement process thru alternative mode of procurement under Section 53.2 Emergency Cases Rule XVII;

**NOW, THEREFORE**, with the foregoing premises, WE hereby resolve that the use of alternative method of procurement under Section 53.2 Emergency Cases Rule XVII for the aforesaid Purchase Request are justified and recommended for approval of the City Mayor as Head of the Procuring Entity, by reason of the existence of the conditions set forth under RA 9184 and its IRR in line with the promotion of economy and efficiency in the procurement system.
