RESOLUTION NO. SP-8797, S-2021

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO EXTEND FINANCIAL ASSISTANCE IN THE AMOUNT OF TEN MILLION PESOS (PHP10,000,000.00), TO THE FOLLOWING MUNICIPALITIES IN SOUTHERN LEYTE, NAMELY: ANAHAWAN, HINUNDAYAN, LIBAGON, PADRE BURGOS, PINTUYAN, SAN FRANCISCO, SAN JUAN, SAN RICARDO, TOMAS OPPUS AND LIMASAWA, AND OTHER MEANS OF HUMANITARIAN SUPPORT BY THE QUEZON CITY GOVERNMENT.

WHEREAS, on 2300H PST of 15 December 2021, the National Disaster Risk Reduction and Management Council (NDRRMC) reported that Typhoon Odette (internationally named Rai) was raised to Tropical Cyclone Warning Signal (TCWS) No. 2 over Southern Leyte;

WHEREAS, on 1100H PST of 16 December 2021, the NDRRMC reported that Typhoon Odette strengthened to Tropical Cyclone Signal (TCWS) No. 4 over Southern Leyte carrying a maximum sustained winds of 195 kilometers per hour (kph) near the center, gustiness of up to 270 km/h, and central pressure of 950 hPa;

WHEREAS, on 1650H PST and 1740H PST, Typhoon Odette made its third and fourth landfall in the municipalities of Liloan and Padre Burgos, Southern Leyte, respectively;

WHEREAS, the following 5th class municipalities in the Province of Southern Leyte were identified by the QCDRRMC to be given financial assistance, namely: Anahawan, Hinundayan, Libagon, Padre Burgos, Pintuyan, San Francisco, San Juan, San Ricardo, Tomas Oppus and Limasawa;

WHEREAS, per Situational Report No. 6 of the NDRRC, as of 0800H of December 19, 2021, a total of 706,634 individuals were directly affected by Typhoon Odette in the Regions of MIMAROPA, Region 5, Region 6, Region 8, Region 10, Region 11, Region 12, CARAGA, and BARMM, including those in the Province of Southern Leyte;

WHEREAS, Section 33 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides for the "cooperative undertakings among Local Government Units by grouping themselves, consolidate or coordinate their efforts, services and resources for the purposes commonly beneficial to them";

WHEREAS, Section 1, Rule 18 of the Implementing Rules and Regulations of Republic Act No. 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010, provides that upon the recommendation of the LDRRMC and approval of the Sanggunian concerned, the LDRRMC may transfer the said fund to support the disaster risk reduction work of other LDRRMC's which are under the state of calamity;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SPECIAL SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to extend financial assistance in the amount of Ten Million Pesos (Php10,000,000.00) or One Million Pesos (Php1,000,000.00) each the following affected municipalities in the Province of Southern Leyte, namely:

- 1. Anahawan
- 2. Hinundayan
- 3. Libagon
- 4. Padre Burgos
- 5. Pintuyan
- 6. San Francisco
- 7. San Juan
- 8. San Ricardo
- 9. Tomas Oppus
- 10. Limasawa
