A RESOLUTION RENEWING THE SPECIAL PERMIT OF GOLDSMITH GAMING CORPORATION TO OPERATE AN ELECTRONIC BINGO (E-BINGO) GAMES AT UNITS A AND B, GROUND FLOOR, TOLEDO BUILDING, NO. 277 TOMAS MORATO AVENUE CORNER SCT. LIMBAGA STREET, BARANGAY LAGING HANDA, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, Goldsmith Gaming Corporation, a domestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, is applying for the renewal of its Special Permit to operate an Electronic Bingo Games at Units A and B, Ground Floor Toledo Building, No. 277 Tomas Morato Avenue corner Sct. Limbaga Street, Barangay Laging Handa, Quezon City;

WHEREAS, Goldsmith Gaming Corporation is primarily engaged in the business of Electronic Bingo (E-Bingo) Games;

WHEREAS, to enable the applicant to operate an Electronic Bingo Games and Traditional Bingo in Quezon City, there is a need to secure a Special Permit from the City Council pursuant to existing ordinance in relation to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, Goldsmith Gaming Corporation is requesting the City Council for the renewal of its Special Permit to operate an Electronic Bingo (E-Bingo) Games.
