RESOLUTION NO. SP-8844, S-2022

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO PALTOK (SFM) CREDIT COOPERATIVE (AS TO FLOOR AREA RATIO, USE AND PARKING) FOR THE CONSTRUCTION AND OPERATION OF A FOUR (4)-STOREY OFFICE/RESIDENTIAL BUILDING TO BE LOCATED AT NO. 18 KUNDIMAN STREET, BARANGAY PALTOK, DISTRICT I, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Paltok (SFM) Credit Cooperative is applying for the issuance of a Certificate of Exception (as to Floor Area Ratio, Use and Parking) for the construction and operation of a Four (4)-Storey Office/Residential Building to be located at No. 18 Kundiman Street, Barangay Paltok, District I, Quezon City;

WHEREAS, in accordance with the provisions of Section 55, Article VIII, in relation to Sections 71 and 73, Article IX of Ordinance No. SP-2502, S-2016, an exception or deviations from the provisions of Zoning Ordinance may be allowed only upon authorization by the City Council;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Certificate of Exception to Paltok (SFM) Credit Cooperative (as to Floor Area Ratio, Use and Parking) for the construction and operation of a Four (4)-Storey Office/Residential Building to be located at No. 18 Kundiman Street, Barangay Paltok, District I, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.
