RESOLUTION NO. SP- 8852, S-2022

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO ZOOM-A TRUCKING SERVICES, INC. FOR THE OPERATION OF A GARAGE FOR DELIVERY TRUCK/VAN: ONE (1)-STOREY OFFICE WITH UPPER FLOOR STORAGE, TWO (2)-STOREY QUARTERS WITH TOILETS AND MOTORPOOL AREA (AS-BUILT) LOCATED AT LOT A-2-B, NO. 99-B TOLENTINO CORNER FLORENCIA STREETS, BARANGAY DEL MONTE, DISTRICT I, QUEZON CITY.

WHEREAS, Zoom-A Trucking Services, Inc. is applying for the issuance of a Special Use Permit for the operation of a Garage for Delivery Truck/Van: One (1)-Storey Office with Upper Floor Storage, Two (2)-Storey Quarters with Toilets and Motorpool Area (As Built) located at Lot A-2-B, No. 99-B Tolentino corner Florencia Streets, Barangay Del Monte, District I, Quezon City;

WHEREAS, pursuant to Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, an exception is required for the aforementioned project only upon authorization by the Quezon City Council;

WHEREAS, the Special Use Permit shall be subject to the following conditions, to wit: (a) the exception will not adversely affect the public health, safety, and welfare, and is in keeping with the general pattern of development in the community; (b) the proposed project shall support economic-based activities and provide livelihood, vital community services and facilities and at the same time, pose no adverse effect on the zone or community; (c) the exception will not adversely affect the appropriate use of the adjoining property in the same district; and (d) the exception will not alter the essential character and general purpose of the district where the exception sought is located;
